We do operate by strict rules and hold high standards, especially on our social media platforms. You are responsible for reading and being familiar with our core Rules. Breach of any of those Rules will result in removal from **Cars & Chai™**. If you do not agree with our Rules, please do not submit your registration. Once accepted as a **Cars & Chai™** member you become part of the family, and we will expect you to abide by our Rules and support the **C&C™** values.

STANDARD OF CONDUCT

The mission of **Cars & Chai™** is to operate at a very high standard and we subscribe to the core values of integrity, loyalty and respect. We consider those elements of utmost importance to us as we seek to attract mature and responsible enthusiasts as members. We truly appreciate your presence in the **Cars & Chai™** family!

The following Standards of Conduct have been established.:

All members will treat each other with common courtesy.

- 1) Personal confrontation, conflict and verbal, visual or physical abuse will not be tolerated.
- 2) Personal criticism or defamation of one individual by another will not be tolerated.
- 3) Personal responsibilities include:
 - a. Complying with all **Cars & Chai™** policies, rules and minimum standards.
 - b. Maintaining appropriate behavior.
 - c. Not assisting others who are attempting to knowingly violate any policy, rule or minimum standard, or are attempting to commit an unethical act.
 - d. Abiding by the rules of an event, when participating in a **Cars & Chai™** event.
 - e. "Flaming" or public attacks in **Cars & Chai™** forums, channels:
 - i. Disagreements between members must be handled in private. If contrary to this, the subject post will be deleted, and the member(s) may be banned.
 - f. Foul language and inappropriate content. We choose to adopt a conservative approach when it comes to language and content that may be considered controversial. This includes content related to the usual topics of race, sex, religion, politics or weaponry. Such posts will be deleted, and we will contact the member. Repeated posts will result in removal from **Cars & Chai™**. Rule of thumb: If you wouldn't say it in person you shouldn't post it.
 - g. Non-car related posts: This is a car group and not a religious, political or else. Such posts will be deleted.
- 4) This a group primarily focused on European exotic and classic automobiles. There are many other forums for other types of automobiles, and one exception is all it takes for **Cars & Chai™** to lose its purpose. On occasion we may choose to post or allow content related to other automobiles as relevant to our members.

REPORTING USERS

We strongly encourage that members help us to improve this community by following the rules and reporting those that do not follow them. Please report any and all rule violations committed by anyone.

RESERVATION OF RIGHTS AND MEMBERSHIP

- 1) Deny association to prospective members whom we deem not interested in promoting or supporting the **Cars & Chai™** purpose or values.

- 2) Remove existing members who knowingly breach or disregard our rules or whom we deem not interested in promoting or supporting the **Cars & Chai™** values. That includes members who choose to join the management team of a club whose purpose or interests' conflict with those of **Cars & Chai™**.
- 3) Remove members who endanger public safety on a **Cars & Chai™** driving event or jeopardize the integrity and reputation of **Cars & Chai™**.
- 4) Invite honorary members – if we believe their association with **Cars & Chai™** will benefit the club and membership as a whole.

Rules of Conduct for Business Promotion
